Regulation (EU) 2016/679, also GDPR, introduced a new approach to the matter and that made an important change of pace by all the actors, starting from the Data Controllers up to the sector specialist consultants, professional figures that were recognized having a primary role also as Data Protection Officers (DPOs)



The principle of **accountability** requires careful and forward-looking behavior: no longer a simple filling of forms but the implementation of constant vigilance, combined with the ability to demonstrate at any time the proactive actions implemented.

Main features of **privacy**evo



privacyevo allows the intuitive management of the Data Controller and all the other roles, leaves you the complete freedom to manage the most complex processing describing them in accordance with the laws, provides the tools for creating, personalizing and the management of documents required by the GDPR; contains the modules for ISO 27001, ISO 27701 and ENISA risk analysis and for the execution of the DPIA (Data Protection Impact Assessment) according to the CNIL methodology integrated into the system



Custom definition of roles. Appointing of Data Processors according to the broadest multilevel decision-making freedom, as well as Data Protection Officers (DPO). Appointment and revocation of persons authorized to process according to the template available in the repository and customizable according your needs.



Processing analysis. Definition of the processing and of the purposes according to infinite possibilities of combination. Management of the processing of special categories of data. Forecast of data transfers to third countries with respect to the European Union. Definition of the categories of data subjects and of any recipients (categories or specific recipients), automated processing including profiling, etc.



Records of processing activities. Automatic generation of records of processing activities of the Data Controllers and Data Processors on the basis of the information in the various sections of the project (personal data, data processing analysis, etc.). Generation of records of the processing activities of the Representatives of the Controllers and Representatives of the Processors where necessary. Manual and programmed generation of registers according to specific needs.



Appointment letters. Letters of appointment and revocation for all the figures involved in the management of privacy (Data Processors, Data Protection Officers, Authorized Persons, System Administrators, Credential Keepers, Data Integrity Managers, etc.)



Rights of the data subjects. Automatic generation of information and consent requests based on the analysis of the processing. Management of information and requests for specific consent for minors and for children under the age of 16 in the case of processing concerning the offer of information society services (art. 8 GDPR).



Risk assessment. Risk analysis carried out according to **ISO 27000** (ISO 27001 and ISO 27701) and **ENISA** standards. Identification and valorization of information, vulnerabilities and deriving threats, calculation of impacts. Determination of risk thresholds and drafting of the related risk **treatment plan**. **DPIA** executable on any processing according to **CNIL** methodology, also with a specific wizard for all the processing formerly defined in the relevant section.
